Public Input Procedures

- Individuals wishing to provide public input regarding matters relevant to the City of Buhl shall:
 - Wait to be recognized by the Mayor or Chairman.
 - Approach the podium.
 - State their name, and whether they are a resident or property owner of the City of Buhl and proceed with their input.
- All public input will be limited to two (2) minutes at the discretion of the mayor. Individuals are not permitted to give their time to other speakers.
- All presenters shall remain respectful.
- This is not a question-and-answer period with Council.
- Public input will not be about any of the items that were on this agenda (as these were not public hearing related topics), personnel, or a personnel-related issue.
 - All issues involving City personnel should be directly communicated with the mayor.

Anyone failing to follow these rules will be provided with one (1) warning. Should the speaker continue to disregard these rules after the warning, they will be asked to return to their seat.

- **Executive Session – ACTION ITEM only to enter and exit executive session.**

Pursuant to provision of Idaho Code 74-206, subsection 1.f:

To communicate with legal counsel for the public agency to discuss the legal ramifications of and legal options for pending litigation, or controversies not yet being litigated but imminently likely to be litigated.
