The proposed amendment are to reflect a reduction of revenue and expenditures due to an error in the Tort amount in the General Fund (Administration Budget), Airport Fund, Streets Fund, and Utilities Fund (Water, Sanitation, and Wastewater Budgets). The proposed amendments are to reflect an additional source of revenue and expenditure in the General Fund (Administration Budget) for the Mayor's Blue Cross Walking Grand and Zion's VISA cash back rewards to be used for sidewalk repairs, the Airport Fund for the Beacon Light Grant Project, the Streets Fund for the remaining payment to close out the TAP 1 & 2 walking path grant, and the Utilities Fund (Wastewater Budget) to purchase replacement storage buildings with ICRMP insurance payment.
