PLEDGE OF ALLEGIANCE

CONFIRMATION OF QUORUM:

Karen Drown confirmed a quorum.

UNFINISHED BUSINESS: There was no unfinished business.

NEW BUSINESS:

Final Review of 2024-2025 Proposed Fiscal Budget: Kelly moved to approve the 2024-2025 Fiscal Budget. Marla seconded the motion. Amanda questioned if this should still be tentative since there hasn't been a public hearing yet. Karen noted this was approving the final numbers to publish the notice of public hearing. Mayor McClain added it was the final night to approve. Amanda questioned how much time do we have to review if someone at the public hearing has questions. Autumn noted a decision would have to be made that night, changes can be made that night but it can only be a decrease to what was published but not an increase. Marla questioned if Amanda had heard from someone. Amanda stated she had heard complaints over the years people feel it is too late and don't feel they are heard. Mayor McClain asked Karen to pull the last two years of minutes for the budget hearing; Mayor McClain added the notice is published in the newspaper. Kelly stated they have gone over it again and again and he doesn't have any concerns and is happy where we are at. Marla added we didn't have much to work with and feel good with what Council has done. She wished they could give raises and hire more. There was no further discussion. There was a roll call vote. Marla voted yes, Amanda voted yes, and Kelly voted yes. The motion passed.

MAYOR & COUNCIL COMMENTS: Mayor McClain read the below statement.

We need to make sure that we comply with the law with regard to employee privacy issues. If a member of the City Council would like to discuss any issues pertaining to complaints, discipline, etc. of a City employee, those will first need to be discussed with the mayor, who is the chief City

administrator per Idaho Code 50-602. After review of the complaint, discipline, etc. if it needs to go before City Council it will be listed under an executive session on the upcoming meeting agenda.

Mayor McClain noted she had not received any comments on the budget for tonight from Michael.

Kelly noted he had been contacted by a friend who would come to the next public comment section with a concern, but Kelly asked to meet with Mayor McClain and Chief Engbaum about the concern.

MEETING ADJOURNED – Kelly moved that the meeting be adjourned. Marla seconded the motion. There was no discussion. All voted yes. The meeting was adjourned at 6:40 PM.
